IPCOC reserves the right to restrict the sale or display of any items it deems not in the interest of running an orderly event. The event is held at an outdoor venue, each vendor is responsible for providing their own equipment; including tables, chairs, awning, extension cords, etc. Vendor must keep booth area clean and will clear booth site of all equipment and debris at the completion of the event.

WAIVER: In consideration of the acceptance of this registration, I the undersigned, assume all risk as well as full and complete responsibility for any injury or accident which may occur to myself or anyone attending with me during the event or while I am on the premises of any of the events, and I hereby release and hold harmless the sponsors, promoters, and all persons or entities associated with this event.
